INDEPENDENT AUDITORS' REPORT

To

1. Report on the Financial Statements

We have audited the financial statements of M/s. Kerala Rural Water Supply and Sanitation Agency, Thiruvananthapuram which comprise of the Balance Sheet as at March 31st, 2017 and the Statement of Income and Expenditure for the year then ended, and a summary of Significant accounting policies and other explanatory information.

2. Management's Responsibility for the Financial Statements

Management is responsible for the preparation of these financial statements that give a true and fair view of the financial position and financial performance of the organization. This responsibility includes the design, implementation and maintenance of internal controls relevant to the preparation and presentation of the financial statements that give a true and fair view and are free from material misstatement, whether due to fraud or error.

3. Auditor's Responsibility

Our responsibility is to express an opinion on these financial statements based on our audit. We have conducted our audit in accordance with the Standards on Auditing issued by the Institute of Chartered Accountants of India. Those Standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial Statements, whether due to fraud or



error. In making those risk assessments, the auditor considers internal control relevant to the organization's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of the accounting estimates made by management as well as evaluating the overall presentation of the financial statements.

The Receipt and Payment of all Grama Panchayats are consolidated and the same is incorporated in the Consolidated financial statements. We have audited the accounts of a representative sample from among the total Grama Panchayats.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion

4. Basis for Qualified opinion

- i. *It was brought to our notice during the course of audit that, there was some embezzlement and/ or mismanagement of funds during the period from 22nd of December 2011 to 31st of October 2016. We have relied on Report for VERIFICATION OF ACCOUNTS OF MALAPPURAM RPMU FOR THE PERIOD FROM 22-12-2011 TO 31-10-2016, conducted by the Finance Division of KRWSA, wherein embezzlement of approximately Rs.7.56 crores was reported at Malappuram Regional Project Management Unit (RPMU) during the period referred to in the Audit Report. Pending vigilance enquiry and consequent recovery proceeding, we are unable to comment on recoverability or otherwise of Rs.6.14crs shown under Other current Assets - Malappuram Embezzlement classified under Loans & advances. Refer note no 2.G.*
- ii. *The Project follows mercantile system of accounting. However based on our review of the books of accounts of the Grama Panchayat (GP) and RPMU, adequate provisions have not been made for various expenditures at the year end. Refer note no 2.J.*
- iii. *Fund-in-transit of Rs.44,75,348/- represent amount transferred to various GP's from RPMU's. The reconciliation of the funds -in -transit as on 31.3.2017 were not available for our verification. In the absence of the*



same the consequential impact if any, on the financial statement is not ascertainable.

- iv. *We would like to bring your attention to Note 2.K on Treatment of Earnest Money Deposit which states that the receipt of EMD is shown as income and the Repayment thereof is shown as expenditure in the year of disbursement which is not in line with Basic accounting principle. On account of the same income is overstated to the extent of Rs 18,04,137, and likewise the expenditure is also overstated to the extent of Rs 49,44,363, Similarly the creditors are understated Rs.31,40,226*
- v. *Proceedings were not made available for our verification in respect of payment made to Kerala Water Authority (KWA) for Rs.220,039,619 out of which utilized amount was Rs.196,756,030, Proceedings were not available for KWA Electricity Arrears Advance amount of Rs. 56,51,607.*

5. Qualified Opinion

In our opinion and to the best of our information and according to the explanations given to us, except for the possible effect of the matters described in the basis for qualified opinion paragraph, the financial statements give the information required in the manner so required and give a true and fair view in conformity with the accounting principles generally accepted in India:

- i. In the case of the Balance Sheet, of the state of affairs of the Kerala Rural Water Supply and Sanitation Agency as at 31st March, 2017, and
- ii. In the case of the Statement of Income and Expenditure of the Incomes and Expenditures for the year ended on that date.



6. Report on other legal and regulatory requirements

- i. We have obtained all the information and explanations which to the best of our knowledge and belief, were necessary for the purpose of our audit;
- ii. In our opinion, proper books of account as required by law have been kept by the Institution so far as appears from our examination of the Said books;
- iii. The Balance sheet and the Statement of Income and Expenditure dealt with by this report are in agreement with the books of account;




