Outcomes/ Highlights of Group Discussions;

Three teams discussed the plan head on scaling up of Rain Water Harvesting and Ground Water Recharge activities. Team members discussed the preparation of RWH and GWR based on the Administrative Sanctions/ Targets and Time lines for completion of each of the activities has been fixed.

The team members belongs to RPMU Idukki and have discussed on the issues, targets on RWH and fixed time line for each of the activities. Target -11 GPs and 275 Units of RWH to be completed by 31^{st} March 2023. RPMU Malappuram has to complete the target of 240 units in 6 GPs and 2 Govt Institutions and RPMU Kannur has a target of 282 units 3 GPs and two Govt Institutions. Strategies to be followed for the timely completion of the activities are Identification of most needed beneficiaries, Awareness creation on RWH storage, components, upkeep of systems, Contract Management, Work execution plan and financial settlement.

Grama Panchayat has to identify most needy beneficiaries and priorities. GPs to prepare and publish the list of beneficiaries and waiting list. If some of the selected beneficiaries have difficulties to build the units due to space constraints next wait listed beneficiary can be given priority. BPL/SC/ST and Fishermen community has to give priority they are exempted from paying beneficiary share. APL families have to pay 10 % of capital cost as beneficiary share.

Three teams region wise had a discussion on plan head "Sustainability Support to Community Managed Water Supply Schemes" They have come out with issues/problems faced in the implementation of the sustainability support programmes and suggest solutions and strategies. The key points are as follows;

<u>Issues</u>

- Inadequate support from the BG for timely mobilization of GP/BG share
- Non-cooperation from GP officials and authorities.
- Non availability of expert hydro geologists
- Shortage of competent contractors
- Rate variation of construction materials
- Inadequate team for yield test
- Minimum follow up in action plan implementation
- Absence of well-defined roles and responsibility
- Delay in processing TA and other allowances
- Reluctance of phase I Jalanidhi schemes for joint ownership
- Continues rain affect source development
- Lack of orientation to BG, GP board & secretary.
- Inadequate support of GWD for hydro geological survey of sources
- Slow processing of fund request of BG & bill of contractors in RPMU/GP/GPST/GPLAC
- Price hike of construction materials
- Low rate of material and work in KRWSA
- Delay in getting GP resolution.
- Absence of complete estimates.
- Absence of competent contractors for well work
- Continues delay in processing of sanctions/approvals from KRFB, PWD, NHAI, KSEB
- Reluctance of GP secretaries for joint ownership of BG & GP and entering in GP asset register with BG resolution without proper land documents.
- Fund release proceedings of KRWSA & A3 agreement of sustainability support project instructed GP secretaries to ensure a joint ownership of BG asset and entering in GP asset register before fund release of fund to GPLAC
- Income and expenditure of certain BGs are not managed through bank accounts

Solutions

- Proper orientation to Beneficiary committee, Grama Panchayat board members, secretary and responsible clerk
- State level intervention to get timely support of GWD for hydro geological survey of sources
- Orientation to RPMU/ GPST / GP staff for a speedy release of payment to GPLAC and contractors
- Specialised group for Yield test to be constituted
- GP wise charge officers for monitoring and continues field level reviews
- Roles and responsibilities of staffs to be reassigned
- Speedy processing of allowances to be executed
- Govt. order for joint ownership of phase I schemes to be issued like Phase II schemes
- Weekly follow up by RPMU level charge officers for timely implementation of GP level action plan.
- Increased participation of RPMU level charge officers in GP board meeting & GPLAC meeting
- Prepare estimate with correct information about charges & rate
- Reduce BG contribution to minimum level. & ensuring the availability of funds from different depts.eg.(SC/ST)
- Support of RPMU & PMU to GPST for mobilizing contractors on difficult work
- Ensure weekly or by weekly meeting of GPLAC with the participation of GPST
- Prepare RPMU level list of suppliers & contractors for each work
- Support of Operations department & District charge officer for coordinating KRFB, PWD, NHAI, KSEB etc.
- Issue GO for joint ownership of BG assets through BG resolution for phase 1 Jalanidhi scheme
- GP level O&M evaluation meeting once in 3 months

After the presentation it is observed that issues and solution alone will not lead to targeted output. Hence micro action plan is required for each plan head. Role clarity of PC & JPC will help full utilization of GPST capacity. The groups were asked to prepare micro activity plan. Absence of proper guidelines is also a concern, so it was discussed in the open forum and a special group was formed to frame a common guidelines for the implementation. Mr. George Mathew, Manager (CD), Kannur is entrusted as moderator. The group had also done a presentation of draft guidelines and salient features of the guidelines is as follows;

- 1. Cost sharing pattern for each of the plan head.
- 2. Criteria for selecting GP, BG and beneficiaries of house hold units
- 3. If GP share is not utilizing for the project, should we take GP AS for the project
- 4. Conditions for including WSS in project.
- 5. Procedures for implementing project in government institutions.
- 6. Roles & responsibilities of GP in each project
- 7. Channelization of fund and installment of fund distribution to contractor of work
- 8. Responsibility of providing TS and maximum estimate sanctioning power of PC, MT and DT
- 9. Responsibility to tender, award and payment for work

- 10. System for tendering, analyzing rate and approval of comparative statement
- 11. Planning & Implementation agreements and signatories on it.
- 12. Monitoring & Evaluation systems of project.
- 13. Billing, recording and payment to contractors of work.
- 14. Banking procedures, tax remittance
- 15. Physical, financial, social, water quality audit of the work.
- 16. Exit procedures of the work

Followed by the presentation it is suggested to conduct RPMU wise group discussions to finalize the project guide line on second day of workshop. Suggestions for the draft guidelines has been called from RPMUs and this guideline can be finalized and submitted for approval.

5. Draft guidelines

One group has conducted discussion on plan head "Conversion of domestic well into protected source of drinking water". Strategies include the selection of beneficiary is entrusted with GPs. BPL/SC/ST and Fishermen families should be given priority. The group discussed activities to be done and tentative action plan has been arrived as follows;

Jal Jeevan Mission challenges and strategies are one of most sensitive discussion point of workshop. 3 groups presented their findings for the consideration of workshop and organization. Following are the key points of presentation.

Challenges

- Non Cooperation of ISAs in beneficiary list preparation & beneficiary contribution collection
- No upper sealing for beneficiary contribution like Jalanidhi in JJM
- No advance beneficiary contribution collection in KWA schemes and KWA GPs
- Non Cooperation of GPs to KRWSA due to the beneficiary contribution collection and GP share demand condition of JJM
- Non availability of GP share for JJM
- Reluctance for road cutting sanction by GP & PWD, NHAI
- Non availability of land for well /pump house/ treatment plant and reservoir
- Ownership of scheme
- Jalanidhi scheme ownership is with GP and BG, their permission for additional tap connection is a difficult task for JJM.
- Majority of Jalanidhi scheme is designed for contribution paid beneficiaries only, capacity of water source, distribution system and tank are inadequate for additional connection.
- KWA's & KRWSA's activities as implementing Agency of JJM in same panchayat create confusion among GP and beneficiaries
- KWA has poor commitment for joint venture project of KWA & KRWSA for timely completion of bulk water purchase scheme structure making,

<u>Strategies</u>

• Maximum beneficiary contribution of JJM should be limited as Rs. 5000/-

- ISAs should be given the responsibility of timely mobilization of beneficiaries list preparation through base line survey and beneficiary contribution collection for JJM project
- There should be a system development for beneficiary collection in monthly instalment through ISAs.
- GO for ensuring GP share for JJM project in each financial year.
- Ensure continues follow ups for timely sanctions from respective authorities.
- Facilitate GP initiatives for land to JJM project.
- Ensure effective coordination of ISAs for managing different JJM stake holders and communicating about their responsibilities in JJM project.
- Ensure bulk water availability before joint venture project of KWA & KRWSA and timely completion of structures by KWA for bulk water purchase project.
- 6. RPMU wise Action Plan for Jal Jeevan Mission.

Second day of workshop is started with the recaps of previous day proceedings by 7 team members. They shared the important discussion points of the day, effectiveness of discussions, workshop arrangements and their learnings from workshops. Followed by a presentation on KRWSA bylaw amendment group discussion. The suggestion of the group will be discussed by Core Committee and finalize the suggestion of the group by next week.

Following to this all RPMUs were made group discussion for micro action plan and followed by presentation. Final RPMU wise micro plan prepared is given as attachment.

RPDs of all RPMUs has made their observations on micro planning workshop and shared their expectation for team work for time bound implementation of project in accordance to the micro plan prepared.

Sri. S Venkatesapathy. IAS, Executive Director, KRWSA has attended the valedictory session of the programme. ED has shared his expectation from the workshop. He said from the facial expression of the participants he could recognize that a good discussion had happened and he can see good confidence among the participants.
