**ORDER**

As per Government Orders read as first and third paper above, Administrative approval was issued for a total amount of ₹20.00 crores for implementation of the scheme " Sustainability Support to Community Managed Water Supply" under the Head of Account "2215-01-102-80-P (State Plan).

2. As per Government Order read as second paper above, sanction was accorded for releasing an amount of ₹5 crores (Rupees five crores only) from the Head of Account mentioned above.

3. Vide the letter read as fourth paper above, the Executive Director, KRWSA requested to release an amount of ₹15 crores (Fifteen crores only) from the budget allocation of ₹55.00 crores under the head of account "2215-01-102-80-P.

4. Government have examined the matter in detail and are pleased to release an amount of ₹5 cores (Rupees Five crores only) from the head of account "2215-01-102-80-P" for the scheme " Sustainability Support to Community Managed Water Supply Schemes," subject to the following conditions:

i) The amount released shall be transfer credited to PSTSB a/c in compliance of GO(P) 62/2018/Fin dated 16.04.2018.

ii)The instructions stipulated in Circular. No.8/2018 dated 31.01.2018 and Circular No.84/2008/fin dated 09/12/08 shall be scrupulously followed.

iii)The amount should be utilized for the purpose for which it has been sanctioned.

iv)The Executive Director, KRWSA shall furnish duly authenticated detailed component wise statement of Expenditure and Utilisation Certificate in the prescribed form as appended to the G.O(MS) No.82/2018/Fin dated 06.03.2018 and G.O(MS) No.451/2018/Fin dated 28.11.2018.
