## ORDER

As per Government Order read as 1<sup>st</sup> paper above, Government have accorded sanction for the implementation of Jalanidhi Add on Project (2<sup>nd</sup> Phase). The Executive Director, Kerala Rural Water Supply and Sanitation Agency in the letter read as 2<sup>nd</sup> above has reported to Government that the project activities of Jalanidhi including the project appraisal by World Bank for implementation of the project for Rs.1022 crore within a period of five and half years benefiting 200. Grama Panchayats of the State, has already been completed. Negotiations on Jalanidhi II Project with Government of India and World Bank is scheduled to be held on 24th & 25<sup>th</sup> of October 2011 in New Delhi. One of the important pre requisites of the negotiations is the approval of the Project Implementation Plan by the State Government. Most of the other conditions of negotiations have already been approved. This project envisages drinking water supply to 11.50 lakh population, sanitation facility to 7 lakh population and water security plan for all the Grama Panchayat within the project area. Apart from these, Grama Panchayat strengthening plan, capacity building of stake holders for implementation and institutional strengthening, technical, financial, management support and institutional arrangements have been incorporated in the Project Implementation Plan. The cost sharing pattern envisages share of 64% by World Bank, 19% by State Government, 12% by Grama Panchayat and 5% by the Beneficiary. After completion of the project, the ownership of the project assets will be jointly vested with the Grama Panchayats & the

Beneficiary Groups. Further the Beneficiary Group will be totally responsible for the operation and maintenance of the scheme. He has requested Government to approve the Project Implementation Plan.

Government have examined the matter in detail and are pleased to approve the Project Implementation Plan (PIP) of Jalanidhi Phase II Project with a financial outlay of Rs. 1022 crore benefiting 200 Grama Panchayat of the state over a period of 5 <sup>1</sup>/<sub>2</sub> years, as such submitted by the Executive Director, Kerala Rural Water Supply and Sanitation Agency dated 30.09.2011. The staffing pattern shall be in accordance with the Government Order read as 2<sup>nd</sup> paper above.
