The Onthammal Water Supply Scheme, designed to serve 32 households, is presently in a partially functional condition due to failure of the Valves ,blockage in distribution line and small patch works on tank. In order to restore the scheme to its designed operational parameters and ensure sustainable and uninterrupted water supply, an estimate is proposed for replacement of the damaged Valves and with rectifying the blockage in the distribution line. The proposed works are essential for improving system performance and service delivery to the beneficiary households. Approximate PAC of work excluding GST is Rs.1,25,455.12 /- 2. Keeryagadi palorakunnu Water Supply Scheme, designed to serve 78 households, is presently in a partially functional condition due to failure of the Pipe line ,reduced hydraulic efficiency of the excisting pump set and blockage rectification in water meter and pipe line .In oder to restore the scheme to its designed operational parameters and ensure sustainable and uninterrupted water supply, an estimate is proposed for new pipeline of suitable specification and supply and installation of a new energy-efficent pump set including testing and commissioning. The proposed works are essential for improving system performance and service delivery to the

Madolathilkunnu WSS Water Supply Scheme, designed to serve 32 households, is presently in a partially functional condition due to failure of the Valves ,blockage in distribution line and small patch works on tank and well site . In order to restore the scheme to its designed operational parameters and ensure sustainable and uninterrupted water supply, an estimate is proposed for replacement of the damaged Valves and with rectifying the blockage in the distribution line and plastering and painting on well and OHSR. The proposed works are essential for improving system performance and service delivery to the beneficiary households. Approximate PAC of work excluding GST is Rs.3,03,474.3 /- 4. Theyythamkattil WSS Water Supply Scheme, designed to serve 56 households, is presently in a partially functional condition due to failure of the Valves,reduced hydraulic efficiency of the excisting pump set. In order to restore the scheme to its designed operational parameters and ensure sustainable and uninterrupted water supply, an estimate is proposed for replacement of the damaged Valves and supply and installation of a new energy-efficent pump set including testing and commissioning.. The proposed works are essential for improving system performance and service delivery to the beneficiary households. Approximate PAC of work excluding GST is Rs.3,80,065.93 /- 5. Aroramala WSS Water Supply Scheme, designed to serve 34 households, is presently in a partially functional condition due to failure of the Gravity line , Filter media and Damedged valves. In order to restore the scheme to its designed operational parameters and ensure sustainable and uninterrupted water supply, an estimate is proposed for replacement of Gravity line ,Valves and Filter medium. The proposed works are essential for improving system performance and service delivery to the beneficiary households. Approximate PAC of work excluding GST is Rs.2,64,931.57 /-
