| 4 | Brief Description of Work       | <p>The Valiyamalayil Water Supply Scheme, designed to serve 110 households, is in partially functional condition due to leakage in the pipelines , Blockage in the distribution network has resulted in the distribution of inadequate conveyance of water.Also</p> <p>The Korothumukku Water Supply Scheme, designed to serve 48 households, is presently in a partially functional condition due to leakage in the distribution network and reduced hydraulic efficiency of the existing pump set.. The leakage in the distribution network has resulted in inadequate conveyance of water, while the poor performance of the pump set has adversely affected the pumping time, required discharge, and head.</p> <p>The Kamichery Water Supply Scheme, designed to serve 139 households, is presently in a partially functional condition due to well collapsed and also leakage in the tank.</p> <p>In order to restore the scheme to its designed operational parameters and to ensure a sustainable and uninterrupted water supply, an estimate is proposed for the replacement / repair of the damaged distribution network, rectification works and filter media packing for the well, supply and installation of a new energy-efficient pump set, including testing and commissioning. The proposed works are essential for improving overall system performance and service delivery to the beneficiary households.</p> |
