4	Brief Description of Work	This work is for Construction, Testing and Commissioning of Grey water treatment plant system having a capacity to treat 3KLD per day of waste water at Govt Engineering College Canteen, Sreekrishnapuram Grama Panchayath, Palakkad district after ensuring it's design given by KRWSA. The work also comprises of ensuring the functioning of treatment system after construction by trial running and testing to ensure the treated water parameters are within the standards and maintaining the system for 1 year DLP period. The major objective of establishing Grey water Treatment Plant is to treat the effluent (untreated waste water from Showers, baths, bathroom sinks washing machines, kitchen wash basins etc but not toilet waste) generated in the Govt Engineering College Canteen, Sreekrishnapuram Grama Panchayath before its direct release into natural environment. Waste water may have an adverse impact on human health and environments. Therefore, proper wastewater management is essential.
