4	Brief Description of Work	<p>The Kanakkankkad and Thonippara–Challapotta Water Supply Schemes, serving 27 and 21 households respectively, are presently in a partially functional condition due to system deficiencies. In the Kanakkankkad scheme, the existing storage arrangement is inadequate due to damage to the old HDPE tank, resulting in leakage and water loss. Hence, the proposed work includes construction of a new RCC storage tank of 1000 litre capacity with 4.0 m height. In the Thonippara–Challapotta scheme, the distribution pipeline and water meters are damaged, leading to leakage and improper regulation of water supply.</p> <p>To restore both schemes to their intended operational efficiency and ensure sustainable and uninterrupted water supply, an estimate is proposed for construction of the RCC storage tank for the Kanakkankkad scheme and replacement of the distribution pipeline for the Thonippara–Challapotta scheme, including all allied works. project cost Rs.1314104/-</p>
