4	Brief Description of Work	<p>The Jaladhara Kizhakkanmukk Water Supply Scheme (35 households) and Parappuram Water Supply Scheme (29 households ) are presently in a partially functional condition due to source-related issues and system deficiencies. In Jaladhara Kizhakkanmukk WSS, heavy silt accumulation in the open well, obstruction caused by the existing electric post alignment, and damages in the distribution pipeline have affected regular water supply. In Parappuram WSS, the reduced yield of the old borewell, malfunctioning pump set, and damaged water meter have adversely impacted system performance and service delivery.</p> <p>In order to restore both schemes to their designed operational efficiency and ensure sustainable and uninterrupted water supply, an estimate is proposed for desilting of the open well, shifting of the obstructing electric post, replacement of damaged pipeline, borewell flushing to improve yield, replacement of the defective pump set, and replacement of the damaged water meter, including all allied works, testing and commissioning.</p> <p>The proposed works are essential for improving overall system performance and ensuring reliable water supply to the beneficiary households under both schemes. project cost 544632.00/-</p>
