4	Brief Description of Work	<p>The Kizhakkottu Kadavu Water Supply Scheme, designed to serve 71 households, is presently in a partially functional condition due to blockage in the distribution network and reduced hydraulic efficiency of the existing pump set. The blockage in the distribution network has resulted in inadequate conveyance of water, while the poor performance of the pump set has adversely affected the pumping time, required discharge, and head.</p> <p>The Mangara Meethal Water Supply Scheme, designed to serve 152 households, is presently in a partially functional condition due to blockage in the distribution network and reduced hydraulic efficiency of the existing pump set. The blockage in the distribution network has resulted in inadequate conveyance of water, while the poor performance of the pump set has adversely affected the pumping time, required discharge, and head.</p> <p>The Koyilothara Water Supply Scheme, designed to serve 55 households, is presently in a partially functional condition due to blockage in the distribution network and reduced hydraulic efficiency of the existing pump set. The blockage in the distribution network has resulted in inadequate conveyance of water, while the poor performance of the pump set has adversely affected the pumping time, required discharge, and head.</p>

		<p>The Thayyattummal Water Supply Scheme, designed to serve 56 households, is presently in a partially functional condition due to blockage in the distribution network and reduced hydraulic efficiency of the existing pump set. The blockage in the distribution network has resulted in inadequate conveyance of water, while the poor performance of the pump set has adversely affected the pumping time, required discharge, and head.</p> <p>The Kacherikunnu Water Supply Scheme, designed to serve 176 households, is presently in a partially functional condition due to blockage in the distribution network and reduced hydraulic efficiency of the existing pump set. The blockage in the distribution network has resulted in inadequate conveyance of water, while the poor performance of the pump set has adversely affected the pumping time, required discharge, and head.</p> <p>In order to restore the scheme to its designed operational parameters and to ensure a sustainable and uninterrupted water supply, an estimate is proposed for the replacement/ repair of the damaged distribution network with a new pipeline of suitable specifications, and for the supply and installation of a new energy-efficient pump set, including testing and commissioning. The proposed works are essential for improving overall system performance and service delivery to the beneficiary households.</p>
