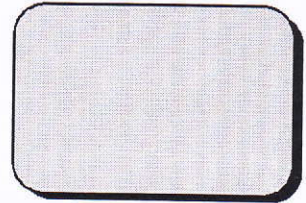

2. Government of India has received a credit from the International Development Association (IDA) in various currencies equivalent to US\$ 1200 Crores towards the cost of the Jalanidhi II Project and intends to apply part of the proceeds of this credit to eligible payments under the contract for which this invitation for quotations is issued.

3. Bid Price

- a) The contract shall be for the full quantity as described above. Corrections, if any, shall be made by crossing out, initialing, dating and re writing.
- b) All duties, taxes and other levies payable by the contractor under the contract shall be included in the total price.
- c) GST in connection with the sales shall be shown separately.
- d) The rates quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
- e) The Prices should be quoted in Indian Rupees only.
- f) Each bidder shall submit only one quotation.

4. Validity of Quotation

Quotation shall remain valid for a period not less than 30 days after the deadline date specified for submission.

5. Evaluation of Quotations

The Purchaser will evaluate and compare the quotations determined to be substantially responsive i.e. which

- g) are properly signed ; and
- h) conform to the terms and conditions, and specifications.

6. The Quotations would be evaluated for the entire item together.

7. Award of contract

The Purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price.

- 7.1 Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.
- 7.2 The bidder whose bid is accepted will be notified of the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the purchase order.
8. Payment shall be made immediately after delivery of the goods. The Supplier has to execute an agreement in Rs.200/- worth Kerala Stamp paper as per approved format.

9. Normal commercial warranty/ guarantee shall be applicable to the supplied goods.
10. No other forms of quotations are accepted.
11. You are requested to provide your offer in the prescribed format enclosed herewith latest by 11:00 hours on 18/01/2018.
12. **Opening of Quotations.**
 - 12.1. The quotations will be opened at 14:30 hours on 18/01/2018.
 - 12.2. Information relating to evaluation of Quotations and recommendations for the award of contract shall not be disclosed to the bidders or any other persons not officially concerned with the process until the award to successful bidder is announced.
