4	Brief Description of Work	<p>The Tippusulthan Water Supply Scheme, designed to serve 88 households, is presently in a partially functional condition due to reduced hydraulic efficiency of the existing pump set, damaged pipelines. The poor performance of the pump set has adversely affected the pumping time, required discharge, and head.</p> <p>The Nechithadam Water Supply Scheme, designed to serve 54 households, is presently in a partially functional condition due to reduced hydraulic efficiency of the existing pump set, damaged pipeline. The poor performance of the pump set has adversely affected the pumping time, required discharge, and head.</p> <p>In order to restore the scheme to its designed operational parameters and to ensure a sustainable and uninterrupted water supply, an estimate is proposed for the replacement/ repair of the damaged distribution network with a new pipeline of suitable specifications, and for the supply and installation of a new energy-efficient pump set, including testing and commissioning. The proposed works are essential for improving overall system performance and service delivery to the beneficiary households.</p>
